MINUTES OF PARISH COUNCIL MEETING Held at 7.00pm on 25 September at Astley Village Hall

38.24 Apologies for Absence

Apologies were received from Councillors E Bedell and K Sumner. Apologies were also received from Flt Lt Mason.

39.24 Disclosable Pecuniary Interests

- a) No disclosable pecuniary interests were declared.
- b) There were no applications for a dispensation regarding disclosable pecuniary interests
- **40.24 Public Participation Session** a period of 15 minutes will be set aside for the public to speak, with a strict 5-minute limit per speaker. Members of the public may speak on matters appearing on the agenda. However, if a matter does not appear on the agenda, a written request should be submitted to the Clerk no later than 2 working days before the meeting.

The requisite notice period had been given advising of the two matters raised:

- The state of Astley Lane hazard to road users, particularly cyclists, due to large clumps of compacted mud and stones deposited on the road by tractors/trailers involved in the recent potato harvesting.
- The status of Project Gigabit within the Parish

The Clerk advised:

- Once the Parish Council had been made aware of the issue with Astley Lane, Highway
 Maintenance at Shropshire Council had been notified. They advised that they will either be
 contacting the responsible landowner and asking them to arrange for the road to be cleared
 or will clear it and then charge the landowner.
 - Such issues can usually be dealt with swiftly if reported via FixMyStreet www.fixmystreet.com, especially if photographic evidence is provided to clearly show the extent of the problem.
- An update has been requested from Freedom Fibre on Project Gigabit with a response received that afternoon, and subsequently published on the website:
 - "Infrastructure build is continuing and ongoing up until Q1 of 2025 for the Astley area. We are making progress with install of cables, drop nodes and civils works.
 - We are in discussions with National Grid about using the existing electricity poles (joint user poles) to serve the premises where new poles are of concern. These discussions are taking some time as contracts and agreements need to be reached
 - The network is expected to be available for some of the residents in the area by the end

of this year, but infrastructure build is continuing and ongoing, anticipated to go on until Q1 of 2025 for the Astley area

- Where any major changes occur, we will keep you informed
- We will be hosting an update webinar within the next two months and will invite Astley Parish Council to attend as soon as we confirm the date."

[Three members of the public left the meeting.]

41.24 To approve the Minutes of the Parish Council Meeting held on 17 July 2024

43.24 To receive reports from

a) Shropshire Councillor

Councillor Picton presented a report which covered:

- Future Options The Future Options survey had recently been emailed to all town and parish councils. As Shropshire Council is facing serious budgetary challenges, it is having to review the level of every service it offers and is therefore exploring every possible opportunity to minimise the impact of any proposed changes on communities. The survey therefore asked if there are any local services that could be taken on by town/parish councils for the benefit of their communities. The Clerk had responded to the survey confirming that the Parish does not have a library nor any leisure facilities so the only service Astley Parish Council could possibly take on in the future would relate to environmental maintenance. However, Shropshire Council does not currently do much verge cutting in the Parish as most hedges are private land.
- Food Waste Collection Questions had been raised regarding food waste and the subscription garden waste bin service. A council does not have to collect garden waste, but it is a service it can choose to provide. It is allowed to make a charge and most councils do. Shropshire Council is charging for this service from 1 October 2024 but as it is forbidden by law from charging for food waste, this cannot go in the garden waste bin. Residents are advised to either put food waste in their general waste bins or to home compost it. From April 2026 Shropshire Council will provide a dedicated food waste collection service.
- Parking Fine Scam it has been reported that text messages are being received claiming to come from either Telford & Wrekin Council or Shropshire Council. The texts claim that a parking offence has been committed and although no details are provided (such as car registration number or location of the alleged offence), a link is provided to click on and pay the fine. Shropshire Council (nor Telford & Wrekin) would ever send a text message requesting any payment.

b) RAF Shawbury

Flight Lieutenant Mason had submitted the following report ahead of the meeting as he was unfortunately unable to attend the meeting in person:

- Night Flying The next night flying period is due to start on 21 October until 5 December. Night flying periods are usually for seven weeks with three weeks in between periods. There will be posts on the RAF Shawbury Facebook/X advising on the night flying periods and we are grateful for the tolerance of this essential training. There is also information on the RAF Shawbury webpage with contact details for complaints or concerns. Night flying will commence typically 30 minutes after sunset and may continue until 02:30.
- Helicopter Liaison Group The Helicopter Liaison Group, previously known as the Helicopter Noise Liaison Group, administered by Shropshire Council, has now been replaced by a 6-monthly newsletter which will be distributed to all Shropshire and Telford & Wrekin town and parish councils. The first newsletter was issued last week and distributed to 180 town/parish councils. There will still be options for regional groups to be addressed by appropriate RAF Shawbury executives if warranted. Hopefully, everyone has seen the latest copy.
